The Company's portfolio of FDA approved brands includes:

- 1 **Caldolor**<sup>®</sup> (*ibuprofen*) Injection, for the treatment of pain and fever;
- 1 **Kristalose**<sup>®</sup> (*lactulose*) for Oral Solution, a prescription laxative, for the treatment of chronic and acute constipation;
- 1 **Omeclamox**<sup>®</sup>-**Pak**, (*omeprazole, clarithromycin, amoxicillin*) for the treatment of *Helicobacter pylori* (*H. pylori*) infection and related duodenal ulcer disease;
- 1 **Vaprisol**<sup>®</sup> (*conivaptan*) Injection, to raise serum sodium levels in hospitalized patients with euvolemic and hypervolemic hyponatremia;
- 1 **Ethyol**<sup>®</sup> (*amifostine*) Injection, for the reduction of xerostomia (dry mouth) in patients undergoing post-operative radiation treatment for head and neck cancer and the renal toxicity associated with the administration of cisplatin in patients with advanced ovarian cancer;
- 1 **Totect**<sup>®</sup> (*dexrazoxane hydrochloride*) Injection, for emergency oncology intervention, to treat the toxic effects of anthracycline chemotherapy in case of extravasation (drug leakage from the bloodstream into the tissues).

Cumberland's pipeline of product candidates includes:

- 1 **Hepatoren**<sup>®</sup> (*ifetroban*) Injection, a Phase II candidate for the treatment of critically ill patients suffering from liver and kidney failure associated with hepatorenal syndrome ("HRS");
- 1 **Boxaban**<sup>®</sup> (*ifetroban*) Oral Capsules, a Phase II candidate for the treatment of asthma patients with aspirin-exacerbated respiratory disease ("AERD");
- 1 **Vascular**<sup>®</sup> (*ifetroban*) Oral Capsules, a Phase II candidate for the treatment of patients with systemic sclerosis (SSc) form of autoimmune disease;
- 1 **Portaban**<sup>®</sup> (*ifetroban*) Injection and Oral Capsules, a Phase II candidate for the treatment of patients with portal hypertension associated with liver disease;
- 1 **RediTrex**<sup>™</sup> (*methotrexate*) Injection, an approval submission candidate for the treatment of active rheumatoid, juvenile idiopathic and severe psoriatic arthritis, as well as severe disabling psoriasis.
